**Regarding 5th Round of Document Verification for Recruitment to Various Posts in
Level-1 against CEN RRC 01/2019**

The provisional list of 142 non-PwBD candidates shortlisted for 5th stage Document Verification (D.V) scheduled to be conducted on **09.06.2026 (Tuesday) & 10.06.2026 (Wednesday)** at the office of RRC/SER, 6th Floor, New Administrative Building (NAB), Garden Reach, Kolkata-700043 is enclosed (Annexure-A) along with the community-wise cut-off marks (Annexure - B).

On the very next working day, DV-cleared candidates will be sent for medical examination. The call letter for Document Verification will be sent to their registered email ids (3-4 days before the D.V). Candidates who do not receive their call letters may communicate through email at: chairmanrrcsergrc@gmail.com. Telephone calls shall not be entertained.

It is hereby informed that, the candidates who remain absent in the 5th round of DV on above mentioned dates for any valid reason, may attend DV on the **block date scheduled on 12/06/2026 (Friday) from 11.30 Hrs at the RRC Office/Kolkata** with same call letter and valid explanation for their absenteeism (only with documentary evidence that the candidate had to appear in a University / Government examination or due to sickness of the candidate from a Government Hospital). No other reason for absence will be considered.

Important Instructions (candidates must follow all the below mentioned instructions):

1. Candidates are strictly advised to report at the venue for the 5th round of Document Verification. No candidate will be permitted to attend document verification after the stipulated time. Candidates must strictly follow instructions of DV officials.
2. There are five stages of Document Verification:
 - i. The first stage of document verification involves marking attendance through a fingerprint biometric system. Each candidate must record their presence using the biometric scanner, which ensures accurate and secure tracking of attendance.
 - ii. In the second stage, candidates are required to mark their attendance in a manual form. This form must include two recent photographs with white background of the candidate, which are attached for identification purposes and for official record-keeping.
 - iii. The third stage is the entry of the identification mark. Each candidate's unique identification mark is recorded to help verify their identity during the process.
 - iv. During the fourth stage, batch-wise document verification takes place. Candidates are verified in their respective batches at assigned locations. All submitted documents are checked thoroughly to ensure they meet the required standards and authenticity.
 - v. Finally, in the fifth stage, candidates who have cleared the document verification are provided with the form for depositing fee (Rs 24/-) for pre-recruitment medical examination. Candidates are advised to carefully fill-in their details on the said form including their name, roll number, and father's name, before proceeding to deposit the fee for the pre-recruitment medical examination.

3. No request for change of "Venue of Pre-Recruitment Medical Examination" will be entertained.
4. No candidate is allowed to leave the DV venue without the permission of RRC-SER officials. If any candidate is found missing during DV after attendance, their candidature will be liable to be cancelled, and no request for reconsideration will be entertained under any circumstances.
5. Candidates must bring a copy of the Application Form and the following certificates in original (along with two sets of photocopies of all documents duly self-attested):
 - a. Mark Sheets and Certificates of all Educational/Technical qualifications mentioned in the Application Form/Notification.
 - b. Gazette Notification and/or any legal document in case of formal change of Name as mentioned in the Notification.
 - c. Certificate as proof of Date of Birth as mentioned in the Notification. In the absence of relevant Certificate/Proof of Date of Birth, candidature of the candidate will be cancelled (Birth Certificate will not be considered as valid documentary proof).
 - d. Caste Certificate for SC/ST (as per Annexure-I of Notification), OBC Candidates (as per Annexure-II of Notification) in prescribed format issued by the Competent Authority. OBC candidates are required to produce OBC Caste Certificate in prescribed format (not older than one year from the date of document verification) as well as valid OBC certificate at the time of application, which should clearly mention Non-Creamy Layer status (as per Annexure-IIA of Notification).
 - e. The caste certificate must be as per the Central List of OBC, ST & SC.
 - f. Income and Asset Certificate for Economically Weaker Section (EWS) (as per Annexure-III of Notification). For this CEN No.RRC-01/2019 the financial year will be 2018-2019 as the closing date of registration is 12.04.2019. Any such Certificate issued even after date of notification will also be considered as Valid on the date of Document Verification.
 - g. NOC from serving employees with Date of Appointment from the current employer.
 - h. Photo Identity Card as mentioned in CEN No. RRC-01/2019 (any one) and photocopy of both sides of Aadhaar Card with Original.
 - i. Receipt of Payment if made through a challan at SBI Branch or Pay-in-Slip at computerized Post Office.
 - j. Income Certificate for waiving examination fee for Economically Backward Classes as per Annexure IIIA.
 - k. Minority Community declaration on Non-Judicial Stamp Paper as per Annexure IV of Notification.
 - l. Self-Certification by the Transgender Candidate.
 - m. J&K domicile Certificate wherever applicable.
 - n. Decree of Divorce/Judicial Separation from the Competent Court of law and Affidavit stating that the Candidate has not remarried, if applicable.
 - o. In case of Widow, Death Certificate of Spouse and Affidavit stating that the Candidate has not remarried.
 - p. Candidate's portion of E-admit card of CBT &/or PET (as applicable).
 - q. Candidates should ensure that all documents are valid, legible, and properly arranged (in 02 separate sets) to avoid delay.
 - r. Candidates are also required to submit an Affidavit as per (Annexure-C) sworn before the hon'ble 1st Class Magistrate at the time of Document Verification.
6. Candidates are also required to carry 04 copies of photographs with white background (size: 3 cm x 3.5 cm) similar to the scanned copy uploaded in the Online Application Form and 12 copies of latest photographs with white background (size: 3 cm x 3.5 cm).

7. Candidates must strictly abide by the instructions given by DV functionaries. Document Verification will be followed by Medical Examination only of those candidates who are found fit by the Screening Committee. Post-medical examination, pre-recruitment checking of documents may be done by units as deemed necessary.
 8. Requests for Change of Venue/ Date of DV will not be entertained under any circumstances.
 9. Signature in the specified areas on the e-Admit Card and Attendance Sheet must tally with the signature of the candidate on the Online Application Form, CBT, and PET. Candidates must put their LTI/RTI in the specified space on the Attendance Sheet in presence of DV committee member/nominated person. Failure to comply may lead to rejection of candidature.
 10. Candidate must surrender RRC copy of the e-Admit Card of DV to the DV committee while retaining the candidate's portion.
 11. RRC/SER reserves the right to order cancellation in case of any candidate or a group of candidates, change of venue/date, or mode of DV.
 12. Furnishing any false information or deliberate suppression of required factual information, detection of which at any stage will render candidates liable for disqualification and debarment from appearing for DV, engagement, or appointment in Railways or any other government job.
 13. In other matters, the terms and conditions laid down in the notice shall apply mutatis mutandis.
 14. Any candidate found obstructing the conduct of the DV or creating disturbances at the DV venue shall be liable to cancellation of candidature and may be debarred from future Railway tests, with legal/criminal proceedings initiated. No re-DV will be conducted if disruption occurs due to instigation by candidates.
 15. In case of walk-out, for any reason, NO re-DV will be conducted and the candidature will be cancelled immediately.
 16. Candidates are being called to fill-up vacancies in safety category posts requiring minimum medical standard of B-1. Candidates shall be sent for fitness in medical category A-2 to B-1 only. No claim for alternate appointment on the grounds of medical unfit in A-2 to B-1 medical category, if any, shall be entertained.
 17. Candidates found eligible in Document Verification will be directed for pre-recruitment medical examination at the nominated Railway Hospital. Candidates shall make their own arrangements for stay for 3-4 days, if required, at their own expense. No TA/DA is admissible.
- Candidates who have been cleared in the Document Verification (DV) stage are required to undergo a pre-recruitment medical examination at designated Railway hospitals. The medical examination memo and call letter will be issued to the DV cleared candidates by RRC-SER and these candidates will be sent to their respective Railway Hospitals over SER on the next working day after DV clearance.
 - Each candidate must obtain a Rs. 24 medical fee memo before issue of medical memo. This receipt is mandatory and must be produced at the hospital along with the medical memo during the medical examination.

- Candidates should strictly follow the hospital's instructions and report on time.
- Candidates are advised to retain copies of all documents and follow the procedure carefully to avoid any delays or complications.
- **Absence on the scheduled date of the pre-recruitment medical examination will result in cancellation of candidature with immediate effect. No second chance will be provided under any circumstances, and no requests or representations will be entertained. Candidates are advised to plan accordingly and ensure timely reporting.**

18.No second opportunity will be provided under any circumstances. Failure to appear on the scheduled date of Document Verification, including block dates fixed for absentees, or failure to produce valid and complete documents, will result in immediate cancellation of candidature.

19.Railway shall not be responsible for any loss/damage caused to candidates during Document Verification.

20.Merely being called for Document Verification does not confer any right for appointment; post allotment is dependent on clearing Document Verification and Medical Examination.

21.All necessary care has been taken while preparing the list for eligible candidates, but inadvertent human errors cannot be ruled out. RRC/SER reserves the right to correct such mistakes whenever noticed.

22.Beware of touts and job racketeers attempting to deceive candidates with false promises. RRBs/RRCs never appoint agents or coaching centres. Candidates are selected purely on merit. Attempts to influence RRB/RRC directly or indirectly will lead to disqualification and possible legal action.

24.Mobile phones, smartwatches, and electronic gadgets may be restricted inside the DV venue; candidates should follow instructions accordingly.
