**NOTICE FOR 3<sup>rd</sup> STAGE DOCUMENT VERIFICATION FOR THE POST OF TRAINS  
MANAGER (GOODS)**

GDCE Notification No. SER/P-HQ/RRC/GDCE/2024

1. Based on the result of Computer Based Test(CBT) conducted on 16.11.2024, 19.11.2024 & 22.11.2024 for the post of Trains Manager(Goods) in Level-5 of 7<sup>th</sup> Central Pay Commission(CPC) against GDCE Notification No. SER/P-HQ/RRC/GDCE/2024, the following CBT qualified candidates are shortlisted for 3<sup>rd</sup> stage document verification on the basis of their merit in the CBT.
2. The following candidates, in order of merit, are provisionally called for 3<sup>rd</sup> stage Document Verification against the resultant vacancies that arose due to unwillingness/ transfer/ medical unfitness, etc of candidates called in previous Document Verifications. 4. Document Verification shall be conducted by the Divisions where the candidates are currently working. The date of DV schedule/time will be intimated by the concerned Divisions.
5. Candidates called for DV will have to be declared fit in **A-2 medical category** and must have their graduation qualification entered in their service records before being finally empanelled.
6. The candidates will have to submit the relevant original documents before the committee nominated for document verification.
7. At least one original and valid photo identification card such as Employee ID, PAN Card, Aadhaar and relieving letter [with photograph] issued by the unit must be presented, failing which candidate will not be permitted in the DV.
8. Original documents and photocopies (self-attested) in support of educational qualification along with mark sheets, Caste certificate (if any) should be submitted to DV officials for verification of documents.



9. Candidate must also bring two color photographs (size 35mm x 35mm), same as which was uploaded in the online application form with clear front view of the candidate without cap and sunglasses.
10. The candidates are provisionally shortlisted for Verification of Documents/Certificates & genuineness of candidature. Merely calling of candidates for DV does not provide any claim for the notified post and candidature is purely provisional.
11. Candidates are also advised to keep the following necessary documents in readiness for appearing in the scheduled DV :-
- (i) Candidate's portion of call letter of CBT in original.
  - (ii) All the original copies of mark sheets, certificates of educational qualification as mentioned in his/her online application.
  - (iii) The cast certificate, in original, if applied for relaxation as reserved community which should have been issued prior to the date of issuance of notification. The same should be as per annexure attached with the notification.
  - (iv) For OBC/Non-Creamy layer candidates, the certificate of community should not be older than one year from the date of issuance of notification. The same should be as per annexure with the notification and should be produced in original.
12. While due care has been taken in preparing in the result, in case of any inadvertent error/s is noticed at any stage RRC-South Eastern Railway reserves the right to rectify it at later stage of selection procedure.
13. This is only provisional result and NOT the FINAL panel and qualifying for Document Verification does not entitle any employee to be appointed on the respective post.
14. RRC-South Eastern Railway reserves the right to declare any employee unsuccessful or delete his/her name from the notified result/panel at any stage of the selection procedure, if any discrepancy or malpractices is noticed or brought to the notice of RRC at any stage. The decision of RRC-SER in the matter shall be final.
